**Evergreen State Shetland Sheepdog Club (ESSSC) dedicates the 2025 Obedience and Rally trials to the memory of Vicki Chalk.**

Vicki owned several Shetland Sheepdogs throughout her life and loved the breed. Vicki was a valued member of ESSSC for over 30 years. She served as President, Vice President, and Secretary. She chaired or was trial secretary for the club's herding trials for many years. She also chaired many obedience and rally trials and was the trial chair of the club's first agility trial. She helped at every agility trial up until this past year. Her support of Shelties in performance events was exemplary. Her bright smile and willingness to take on tasks will be sorely missed by the club and its members.

Vicki adopted "Spirit" from Seattle Purebred Dog Rescue (SPDR) in 1991 with the goal of showing him in competition obedience. Spirit earned his Utility Dog (UD) title and earned his AKC Herding Championship (HC). Vicki's Sheltie "Sherman," also earned his AKC Herding Championship. Over the past 6 years Vicki adopted 4 more Shelties via SPDR.

In addition to being a long-time member of ESSSC, Vicki was also a member of the American Shetland Sheepdog Association (ASSA) for over 25 years and was an active member of the All Breed Herding Club of Western Washington (ABHCWW).

Vicki was preceded in death by her husband Earl and is survived by her stepdaughter Teri.

**Transfers** will be accepted for this trial according to Chapter 1, Section 16 of the AKC Obedience and Rally Regulations.

**Females in season** are not permitted to compete. If a female is withdrawn from competition because it came into season and the event secretary is notified no later than one half hour prior to the start of the first class in the trial, the club will refund the entry fee.

**Faxed, Telephone, and Unsigned Entries cannot be accepted.** Mailed entries not on Official AKC Entry Forms and photocopies of AKC Entry Forms without ***Agreement and Rules*** on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.

**Acknowledgement of the receipt of entries will be sent by email only, or by regular mail, if requested.**

Acknowledgment of entries will be made as soon as possible after the closing date with the Judging Program and directions to the Trial Site. Should such acknowledgment not be received by the exhibitor within a reasonable time, please contact the Trial Secretary.

**AKC Event & Recording Fees** The American Kennel Club will collect the following at every Licensed or Member club event: • First entry of a dog in Obedience, a \$3.00 Event Service Fee and \$.50 Recording Fee, plus a \$3.50 Service Fee for each additional entry of the same dog. • First entry and each additional entry of a dog in Rally, a \$3.50 Service Fee.

**No Entry shall be made, and no entry shall be accepted which specifies any condition as to its acceptance.**

**Entry fees shall not be refunded** in the event that a dog is absent, disqualified, excused by a veterinarian or judge or barred from competition by action of the Trial Committee.

If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the trial, no refund of entry fees will be made.

**Post-dated and returned checks do not constitute a valid entry fee.** The trial-giving club will add a collection fee in the amount of \$25.00 for each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

**Errors on entry forms. Owners are responsible for errors in making out entry forms,** whoever may make such errors, and no entry fee will be refunded in the event of such errors or cancellations of entries after the published closing date.

**Dogs may arrive any time prior to their scheduled time of judging.** Dogs not required for further judging will be excused.

**Judges need not wait for any dog holding up a class.** Reasonable accommodations for conflicts between obedience and rally need to be agreed by the judges on the day of the trial.

**All dogs present must be held on leash or confined to their crates,** except when being judged.

**For safety reason, no flexi leashes permitted in the buildings.**

**No smoking is allowed in the building.**

**The club may cancel the event due to extreme weather conditions.**

**Neither the Trial Committee nor ESSSC nor MRSSA will be responsible** for the loss or damage to any dog on the trial grounds, whether as a result of an accident or any other cause. It is clearly understood that every dog entered in the trial is in the care, custody, and control of its owner or handler, during the entire time the dog is on the trial premises.

**Transfers will be approved in accord with Chapter 1, Section 16** of the Obedience Regulations and the Rally Regulations, provided that a written request is submitted to the Trial Secretary at least 30 minutes prior to the start of the Trial, and that the limit has not been reached in the requested class.

**Due to limited space there will be NO INDOOR CRATING allowed with the exception of trial workers and disabled exhibitors. Pop-up canopies may be set up on the lawn outside the building.**

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
